**LOTTERY PROCESS**

1. Students will be placed on the waiting list by a random selection process.
2. The waiting list is valid for the 2010-2011 school year. If the student is not accepted for this school year, you must apply again next year.
3. As vacancies occur, applications will then be screened for acceptance in the order in which they appear on the waiting list. An opening only exists in grades 1-8 when a student leaves the school. You will be contacted if an opening becomes available for your child.
4. If the applicant does not meet the screening criteria for acceptance, the next name on the waiting list will be screened.

**SIBLING POLICY**

Within the context of this policy, siblings are defined as children who reside in the same household with a common parent or legal guardian. Priority admission will be granted to applicants for grades K-3 with a sibling(s) currently attending grades 1-7 in the same magnet school to which they have applied provided the applicant meets the requirements for admission. This policy applies only to those students born by February 13, 2006, who have a sibling in a magnet school as of the 2005-2006 school year. The policy will no longer apply to students who have entered after the 2005-2006 school year.
